Modi to transfer first installment of PMAY-G to 1.47 lakh?

New Delhi (Hindustan Sunamchar) Prime Minister Shri Narendra Modi will transfer the first installment of Pradhan Mantri Awas Yojana - Gramin (PMAY-G) to more than 1.47 lakh beneficiaries of Tripura on 14th November, 2021 at 1 PM via video conferencing. More than Rs 700 crore will be credited directly to the bank accounts of the beneficiaries on the occasion. Following Prime Minister's

intervention, taking into account unique geo-climatic condition of Tripura, the definition of 'kuccha' houses has been changed specifically for the state, which has enabled such a large number of beneficiaries living in 'kuccha' houses to get assistance to construct a 'pucca' house. Union Rural Development Minister and Chief Minister of Tripura will also be present during the event.
